

The minutes of the ICC meeting conducted on 15/03/2024 were approved without changes.

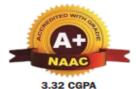
# Agenda 2: Complaints Lodged by Students/Staff Members



The minutes of the ICC meeting held on 22/03/2024 were confirmed and approved.


#### Agenda 2: Complaints Lodged by Students/Staff Members


