Resource Mobilization Policy and Procedures of the Institution

I) Recurring Sources

> Fees Receipts

Students are admitted as per Maharashtra Government Higher Education norms. The fees amount collected from students. As per the norms laid by the Fees Fixation Committee of State Government, fees amount is collected from each student. This amount is spent for recurring expenses i. e. Electricity, Maintenance and vehicle fuel etc. and part of infrastructural development activities as well.

II) Non-Recurring Sources

> Entrepreneurship development in India Encouraging Trends

The college conducts various programs and seminars for students' self-supporting development and submits the detailed proposals to get grants for the same.

> State of the Art Indoor Stadium

A huge, Indoor multipurpose stadium with the seating capacity of 350 persons. This auditorium is used to internal colleges for their activities and charges are used for the development of this college especially for infrastructural development.

> Non Government Bodies and Sponsorship Receipts

Donations are received from Institutions well wishers (i.e. alumni and others) and Philanthropists for students' research and project activities. The college also gets various sponsorships from industries, private firms and individuals.



> Corpus Donation of Trust and Trust Contribution

The institution is functioning under Vidarbha Bahu Uddeshiya Shikshan Santha, Nagpur, Maharashtra. The Trust is registered under Bombay Trust Act 1950. This fund is transferred to the institute to develop the Institution's academic activities as well as to meet the infrastructural expenses.

Fund generated from above are principally used for maintenance and development of Institution. To facilitate the above initiatives, the institutions provide space to various academic facilities for students, faculty members and officials of the institutions.

Optimum utilization of funds is ensured through:-

- Adequate funds are allocated for effective teaching-learning practices that include orientation Programs, Workshops, Inter-disciplinary activities, training programmers', refresher Courses that ensures quality education.
- ➤ Budget is utilized to meet day to day operational and administrative expenses and maintenance of fixed assets.
- ➤ Enhancement of library facilities needs to augment learning practices and accordingly requisite funds are utilized every year
- Adequate funds are utilized for development and maintenance of infrastructure of the University.
- > Some funds are allocated for social service activities as part of social responsibilities through NSS.
