## Minutes of the meeting

Prof. Ritesh Banpurkar, Dean of IQAC, extended a warm welcome to Dr. Sandeep Gaikwad, Treasurer of GPGI, Dr. Premanand L. Naktode, Principal, Dr. Pragati Patil, Vice-Principal, as well as all directors, deans, department heads, and IQAC members. He provided an overview of the proposed agenda for the meeting.

Following discussion/decision were held/taken in the meeting

Item-01: Confirmation of Minutes from the Last IQAC Meeting

Prof. Ritesh Banpurkar provided a detailed review of the minutes from the previous meeting. He systematically revisited each agenda item discussed during that meeting. The committee members thoroughly reviewed all points addressed in the last session.

**Resolution:** The expert members of the IQAC committee unanimously confirmed the minutes of the previous meeting.

**Item-02:** Update on NBA Accreditation for Electrical and Mechanical Engineering. Prof. Anup Gade, the NBA Lead Coordinator, informed the committee that the Mechanical Engineering (ME) and Electrical Engineering (EE) undergraduate programmes have successfully received NBA accreditation. All members expressed their satisfaction with this achievement.

**Resolution:** The committee members commended the efforts of the staff in securing NBA accreditation for the mentioned programmes. The resolution was passed unanimously.

Item-03: Update on Submission of Pre-Qualifier for CE and ECE

Prof. Radharaman informed the committee that the college had applied for accreditation of the CE and ECE programs and successfully submitted the pre-qualifier. Dr. P. L. Naktode instructed the NBA Lead Coordinator to establish core committees for both departments to ensure the timely preparation of the Self-Assessment Report (SAR) within the set deadline of April. The members expressed confidence in achieving NBA accreditation for these programs.

**Resolution:** The submission of the pre-qualifier for CE and ECE programs for NBA accreditation was unanimously approved.

**Item-04:** Discussion on Standard Operating Procedure (SOP) for conduction of Faculty Development Programs (FDPs).

Prof. Ritesh Banpurkar presented a detailed plan for conducting Faculty Development Programs (FDPs) and shared the proposed Standard Operating Procedure (SOP) for their implementation. During the discussion, Mr. Amol Pusdakar inquired about involving industry professionals in FDPs. Dr. P.L. Naktode recommended that at least two resource persons should be invited from IITs or NITs to ensure high-quality sessions. Prof. Pragati Patil emphasized that for online FDPs, a minimum of 100 participants should be mandatory for the program to be conducted. Additionally, Dr. P.L. Naktode suggested that each department should organize FDPs on emerging topics relevant to their respective disciplines to support faculty development.

**Resolution:** The committee unanimously approved the proposed SOP for Faculty Development Programs, incorporating the suggestions discussed, including industry involvement, expert participation from IITs/NITs, a minimum participant requirement for online programs, and department-specific emerging topics.

**Item-05:** Review of Co-Curricular and Extracurricular Activities Conducted in the Odd Semester and Activity Calendar for the Even Semester.

Prof. Ritesh Banpurkar presented a summary of the co-curricular and extracurricular activities conducted during the odd semester and shared the proposed activity calendar for the even semester. Mr. Vikas Mishra suggested organizing national-level activities to enhance student development. The members expressed satisfaction with the number and quality of activities conducted.

Regarding the activity calendar, Dr. Sandeerp Gaikawad proposed organizing an Alumni Meet during the Holi festival as a "Holi Milan" program.

**Resolution:** The committee unanimously approved the review of activities and the activity calendar for the even semester, including the suggested Alumni Meet during Holi.

## Item-06: UG NEP 2020 Rules and Regulations.

Prof. Anup Gade presented the draft of the UG NEP 2020 rules and regulations to the committee. During the discussion, Dr. Sandeep Gaikwad emphasized the importance of including all guidelines outlined by the Government of Maharashtra's GR. Prof. Anup Gade assured the committee that the institute had fully incorporated all government-mandated guidelines into the regulations.

**Resolution:** The committee reviewed and approved the UG NEP 2020 rules and regulations, acknowledging that all government guidelines have been duly incorporated. The resolution was passed unanimously.

# Item-07: Information about placement scenario of institute.

Dr. Nitin Chore, Dean of Training and Placement, shared that 266 students have been successfully placed. Placement statistics and a list of companies visiting the campus were displayed for the members' reference. Additionally, 370 students completed internships, with the highest placement achieved in the Mechanical Engineering program. The top internship companies were also showcased, and the highest package offered was ₹7.25 lakhs.

Dr. Sandeep Gaikwad expressed concerns about the low placement percentage in the ECE and CSE branches. He inquired about the stipends provided to students during internships and suggested that the Training & Placement (T&P) Cell negotiate for non-monetary benefits such as free transportation and meals, which should be encouraged.

Dr. P. L. Naktode emphasized the goal of placing at least 50% of students and urged the T&P Cell and faculty to put in greater efforts to achieve this benchmark, as it is critical for securing NBA accreditation. He also highlighted the importance of communication and soft skills training for students, noting that language barriers and a lack of communication skills should not prevent technically capable students from securing placements.

Dr. Nitin Chore informed the members that a mega placement drive is being planned to improve placement outcomes.

**Resolution:** It is resolved to note the suggestions made by the Members of the IQAC and act accordingly." The Resolution passed unanimously.

# Item-08: Any other point with the prior permission of the Chairman.

**Resolution:** With the prior permission of the Chairman, and as there were no further agenda items for discussion, the Dean of IQAC Prof. Ritesh Banpurkar proposed a vote of thanks and concluded the meeting.

#### Suggestions and Concluding Remarks:

Dr. Sandeep Gaikwad recommended prioritizing improvements in placements, particularly in core branches, as they have a direct impact on admissions. He also proposed exploring the commercialization of patents. Additionally, he suggested enhancing efforts to improve the institute's NIRF ranking, aiming to position it within the top 200 NIRF institutions. One way to achieve this would be by increasing the number of research papers published.

Mr. Amol Pusadkar expressed that there should be a motivational change in the overall activities and performance of the institute. He suggested institute should work on interaction with industries to improve the consultancy parameter He further suggested that domain-specific subjects can be added to the curriculum. He suggested the new curriculum can be framed taking into consideration the ground reality of the domain-specific courses.

Mr. Vikas Mishra highlighted the importance of strengthening industry-institute interaction to ensure that industry-required skills are effectively integrated into the curriculum. He suggested that maximum inputs should be delivered by industry professionals or faculty members who have undergone training in relevant companies. Expressing concern over the low number of students clearing aptitude tests during placement drives, he recommended implementing focused efforts to enhance students' aptitude and preparedness.

Mrs. Amrapali Kamble stressed the importance of fostering industry-institute interactions to ensure that the curriculum addresses the skill requirements of the industry.

Dean of IQAC Prof. Ritesh Banpurkar thanked all IQAC members & invitees for their suggestions & meeting was concluded at 4.00 pm.
