Policy on Fee Adjustment and Re-admission

1. Fee Adjustment for DC Students

- ✓ DC students of our College are eligible for a fee adjustment if they request a refund within one year from the date of payment.
- ✓ Request Submission:
 - Students must submit a written request for a fee adjustment to the Accounts Department.
 - o The request must include:
 - Student's full name & ID number
 - Date of fee payment
 - Reason for the refund request
 - The request can be submitted in person to the Accounts Department.
 - Processing the Request:
 - The Accounts Department will verify the details and ensure the request is within the eligible timeframe.
 - The verification process will take up to 10 working days.
 - Approval and Adjustment:
 - Upon approval, the fee adjustment will be processed.
 - The adjusted amount will be refunded to the student's bank account within 15 working days.
 - o Forfeiture of Fees:
 - If the refund request is made after one year, the fees will be forfeited, and no adjustment will be made.

2. Readmission and Absorption Fees

- o Eligibility for Readmission/Absorption:
 - Students seeking readmission or absorption must meet the academic and administrative requirements set by the college.
- o Application for Readmission/Absorption:
 - Students must submit a readmission/absorption application form to the Admissions Office.
- o The application must include:
 - Student's full name & ID number
 - Previous program details
 - Desired program for readmission/absorption
 - Reason for readmission/absorption
- o The application can be submitted in person to the Admissions Office.
- o Review and Approval:
 - The Admissions Office will review the application and verify the eligibility criteria.
 - The review process will take up to 10 working days.
- o Fee Payment:
 - Upon approval, students must pay the applicable readmission/absorption fee as follows:
 - Soft Programs (CSE, IT, Data Science): Rs. 40,000
 - Other Programs (Rest of All Excluded Above): Rs. 25,000
 - Polytechnic Programs: Rs. 20,000
 - Payment can be made via bank transfer, online payment portal, or in person at the Accounts Department.
- Confirmation of Readmission/Absorption:
 - Upon receipt of the fee payment, the student's readmission/absorption will be confirmed.

This policy is effective and applies to all current and prospective students of Gaikwad Patil Group of Institutions.
