**POLICY OF THE TULSIRAMJI GAIKWAD-PATIL COLLEGE OF
ENGINEERING & TECHNOLOGY ALUMNI ASSOCIATION, NAGPUR-
441108 (MH)**

It is hereby declared that Tulsiramji Gaikwad-Patil College of Engineering & Technology Alumni Association (herein after referred as "The Association") shall function under and according to the jurisdiction of the society, Nagpur District.

I. NAME OF THE ASSOCIATION

The name of the Association shall be "Tulsiramji Gaikwad-Patil College of Engineering & Technology Alumni Association"

II. DEFINITION

Unless otherwise expressly stated or construed by context the following terms shall have the following meanings for the purpose of this byelaw and constitution of Association mentioned in all matters concerning the Association.

1. The Society or Organization of the Association shall mean "Tulsiramji Gaikwad-Patil College of Engineering & Technology Alumni Association"
2. "General Body" means the General Body of the members of "Tulsiramji Gaikwad-Patil College of Engineering & Technology Alumni Association" consists of one President, one Vice Presidents, one Secretary, one Joint Secretary, one Treasurer and two or more members.
3. "Bye Law" means the body of rules and regulations contained in the document.
4. "Constitution" means the Constitution of "Tulsiramji Gaikwad-Patil College of Engineering & Technology Alumni Association"
5. "Institution" means the "Tulsiramji Gaikwad-Patil College of Engineering & Technology"
6. "Parent Organization" means "Tulsiramji Gaikwad-Patil College of Engineering & Technology Alumni Association"

III. OFFICE OF THE ASSOCIATION

The Office of the Association shall function in the campus of the "Tulsiramji Gaikwad-Patil College of Engineering & Technology, Nagpur-441108"

IV. AREA OF OPERATION OF THE ASSOCIATION

1. The area of operation of the Association shall be within the campus of Tulsiramji Gaikwad-Patil College of Engineering & Technology, Nagpur-441108
2. The Alumni Chapters can be formed within and outside India subject to the approval and concurrence from the parent organization. All activities of Chapters should be conducted to uphold the dignity of the parent Chapter.

V. OBJECTIVES.

The objectives of the Association shall be:

- a) To maintain the contacts of the Alumni with the alma-mater
- b) To foster the relationship between the past and present students of the institution.
- c) To keep the old students informed of the growth and development of the institution.
- d) To give an opportunity to the old students of the institution to take part in the responsible tasks of building up and maintaining the traditions of the institution.
- e) To serve as a forum striving to get a proper blending of the theoretical and practical aspects of the Engineering.
- f) To contribute institute prizes, scholarships, book banks etc. for the students of the College.
- g) To help the students passing out of the College in securing employment consistent with their qualifications.

VI. RULES AND REGULATIONS.

1. MEMBERSHIP

All the past students of the College shall be eligible to become members of the Association.

2. There shall be four classes of members.

a) PATRONS

The Founder of the Institution, the Chairman and Members of the Governing Body, and the Principal of the College shall be Patrons of the Association. The General Body may invite other outstanding personalities to be Patrons of the Association.

b) LIFE MEMBERS

All those former students of the College who have registered themselves shall be considered as life member.

c) HONORARY MEMBERS

All members of the Teaching Staff of the College shall be Honorary Members of the Association.

d) ASSOCIATE MEMBERS

All former members of the alumni association of the College shall be eligible to become Associate Life Members or Associate Members of the Association.

3. Patrons, Honorary Members, and Associate Members shall be use all the privileges of the Association except that of voting in the Annual General Body Meeting.
4. During any year the Association shall consist of all the Patrons, Life Members, Honorary Members and Associate Members.
5. The affairs of the Association shall be management by the General Committee consisting of one President, one Vice Presidents, one Secretary, one Joint Secretary, one Treasurer and two or more members. The General Committee shall have the power to constitute Sub Committees to further activities of the Association.
 - a) The President of the Association shall be selected from amongst the former students.
 - b) One Vice-President shall be selected from amongst the former students of the College.
 - c) One Secretary shall be selected from amongst the former students of the College.
 - d) The Treasurer shall be selected from amongst the former students of the College.
 - e) Two faculty as a members of alumni association.
6. All the office bearers of the Association shall be selected once in a year of the Annual General Body Meeting of the Association which shall be held once in the academic year of the College.
7. Students of the final year class of the College shall have the right to participate.
8. The General Committee shall have the power to incur from the general funds of the Association all expenditure necessary for carrying out the objects of the Association.
9. In addition to the Annual General Meeting of the Association prescribed in Rule 6, Extraordinary General Meetings may be called on the written requisition of not less than 30% members of the Association.
10. The quorum for a Meeting of the Association shall be twenty five percent.
11. There shall be an Annual Audit of the accounts of the Association by an External Auditor (Chartered Accountant). No member of the General Committee shall be appointed as an Auditor.
12. The General Committee shall have the power to frame bye-laws which are not inconsistent with these rules.

13. The official year of the Association shall be April 1st of one year to the 31st March of the succeeding year, and the Annual subscription is payable in advance.

14. LEGAL PROVISION

1. The provisions of Registrar of Societies, Maharashtra State are applicable in whole to the activities of the Association.
2. Courts in Nagpur City alone have jurisdiction to entertain as it against Association.

15. FORMATION OF ALUMNI CHAPTERS OUTSIDE INDIA.


Alumni Chapters outside India may be formed based on the aims, objectives and regulations of the Tulsiramji Gaikwad-Patil College of Engineering & Technology Alumni Association. i.e. the parent body and such Chapters also shall initiate themselves to get necessary authentication by Indian Embassy/Consulate.




16. GUIDELINES TO THE CHAPTERS WORKING IN INDIA AND ABROAD
